Subject: **Sanction for training in Macau.**

The undersigned is directed to convey the sanction of the Anti-Corruption Commission, Bangladesh for the following officers to attend the training programme on “Anti-Corruption and Investigation Procedure of CCAC” in Macau from 16 to 17 January 2019 under the following terms and conditions:

- (a) The period of the training including transit will be treated as on duty;
- (b) They will draw their usual pay and allowances from the ACC, Bangladesh in local currency;
- (c) All expenses regarding this visit will be met from the development budget of the project titled “Strengthening the Anti-Corruption Commission”;
- (d) Any other allowances/expenses and taxes admissible under relevant rules/regulations will be drawn from the budget of Anti-Corruption Commission;
- (e) They will leave Dhaka for Macau on 14 January 2019 or the nearest possible date and leave Macau for Dhaka on 19 January 2019 or the nearest possible date;
- (f) On return from abroad, they will report to their present place of posting;
- (g) They will not be allowed to stay abroad for more than the approved period; and
- (h) Each of the participants has to present a paper on his/her learning experience to the DG (administraion) within 15 days of return from the training program.
