Terms and Conditions:

 - (c) All expenses regarding this visit will be borne by Anti-Corruption Commission;
 - (d) Any other allowances/expenses and taxes admissible under relevant rules/regulations will be drawn from the budget of Anti-Corruption Commission; and
 - (e) They will leave Dhaka for Russian Federation on 22 January 2019 or the nearest possible date and leave Russian Federation for Dhaka on 26 January 2019 or the nearest possible date.
2. After visiting the office of the Investigative Committee of the Russian Federation Hon'ble Commissioner Dr. Md. Mozammel Haque Khan will go to Singapore for medical check up on 26 January 2019 and he will leave Singapore for Dhaka on 29 January 2019 or the nearest possible date.
