- (e) They will leave Dhaka for Hong Kong on 02 January 2019 or the nearest possible date and leave Hong Kong for Dhaka on 12 January 2019 or the nearest possible date;
- (f) On return from abroad, they will report to their present place of posting; and
- (g) They will not be allowed to stay abroad more than the approved period.
